## **Results of the call for expression of interest in the introduction of the European Professional Card**

On 18 October 2013, the Commission published a [call for expression of interest](#) inviting representative professional organisations and associations at national and EU level to express an interest in the introduction of the European Professional Card (EPC).

By 22 November 2013, the Commission received replies from the professional organisations and associations which are listed in Annex I, and spontaneous comments from other stakeholders, such as competent authorities, which are listed in Annex II.

### **Next steps**

In order to streamline the process and make sure that it can be delivered by the end of the transposition period, the Commission proposes to continue the work regarding the introduction of the EPC with a limited number of professions.

The professions which have already expressed their interest, but are not retained by the Commission at this stage, and the professions which will manifest sufficient interest in the future, will be considered for the introduction of the EPC at a subsequent stage.

As provided by the Professional Qualifications Directive, as amended, the introduction of the EPC shall be subject to the following conditions (Article 4a(7)):

- “(a) there is significant mobility or potential for significant mobility in the profession concerned;*
- (b) there is sufficient interest expressed by the relevant stakeholders;*
- (c) the profession or the education and training geared to the pursuit of the profession is regulated in a significant number of Member States.”*

After a preliminary review of the characteristics of the professions who expressed an interest in the introduction of the EPC, the Commission considers that at this stage a more thorough

assessment has to take place in relation to the following professions which seem to fulfil to a large extent conditions imposed by the Professional Qualifications Directive, and without prejudging the final selection of professions for the EPC:

- a) doctors
- b) nurses
- c) pharmacists
- d) physiotherapists
- e) engineers
- f) mountain guides
- g) real estate agents.

On the basis of the interest expressed by the professional organisations and associations, the Commission invites all stakeholders related to the professions mentioned under point a) to g) above, and in particular the competent authorities empowered to receive applications and to take the decision on the recognition of professional qualifications for these professions, to comment on the interest expressed by these professional bodies to benefit from the EPC.

These comments should be sent to [markt-e4-epc@ec.europa.eu](mailto:markt-e4-epc@ec.europa.eu) no later than 10 January 2014 and, as much as possible, motivated against the conditions for the introduction of the card. Comments by competent authorities already submitted to the Commission on this issue will be taken into account. In that respect, the competent authorities do not have to resubmit their comments if they do not want to. All comments received will be published on the website of the Commission unless otherwise requested by the author of the comment. In addition, in early 2014 the Commission intends to contact the relevant stakeholders by means of questionnaires.

The Commission will also initiate a more in-depth analysis of the fulfilment of the conditions for the introduction of the EPC by these professions. It will propose the introduction of the card only for those professions which fully meet the selection criteria, taking also into account the need to ensure a smooth introduction of this new recognition process.

The Commission intends to set up a focus group to play an active role in the forthcoming discussions regarding the functioning of the EPC. The group will consist of a limited number of participants, including representatives of professional organisations at EU level as well as Member State competent authorities for the professions for which a more thorough assessment is undertaken at this stage. The first introductory meeting will take place on 31 January 2014, and will be followed by further meetings in the first trimester of 2014.
